## About MTPConnect

## Role Overview

MTPConnect's Board also hopes to gain new perspectives from you and learn about the challenges and opportunities you face as an emerging leader in the MTP sector. The Board is committed to the promotion of cognitive diversity.

As a Guest of the Chair you will be responsible for preparing for, and making yourself available for travel to Board meetings and engaging with the Chair and other MTPConnect personnel in seeking to maximise the benefit from this experience. Guests do not assume the status of a Director and have neither the rights nor responsibilities of being a Director. MTPConnect will also offer to cover half the cost of your Australian Institute of Company Directors (AICD) course, if you have not completed it.

In your role, you will be expected at all times to act in the best interests of MTPConnect, to comply with MTPConnect's Constitution (as it applies to you in your Role) and all of MTPConnect's policies, including the Standing Orders on Guests Attending Board Meetings. As Guest of the Chair you may be invited to speak at Board meetings in accordance with the Standing Orders.

In addition, at the completion of your Role, you will agree to be interviewed for a potential case study to showcase the experience and learnings including impact you gained in your Role. You acknowledge that your interview may be shared more broadly with the MTP sector with a call for more Boards to utilise this opportunity to mentor potential future directors and you agree to provide all necessary consents for your interview to be so shared.



## Key Selection Criteria

The ideal candidate for the position of Guest of the Chair will be an emerging leader with a diverse background in the MTP sector who has:

- Not previously had board or CEO experience;
- A strong interest in corporate governance;
- An international focus with experience in Asia; and
- Working knowledge and experience from within the MTP sector.

The Guest of the Chair will:


- Act with integrity and professional discretion;
